Saint Lucia has received financing from the World Bank towards the Disaster Vulnerability Reduction Project (DVRP) and intends to apply part of the proceeds for consulting services for engagement of a Project Manager.

The consulting services (“the Services”) include to provide overall and day-to-day management of the project activities to be implemented and to provide the necessary supervision of staff, consultants and others engaged under the Disaster Vulnerability Reduction Project and so ensure full compliance of all parties to their contractual commitments. The project Manager Position is full-time and will substantially be performed on site at Project Coordination Unit, Department of Economic Development, Transport and Civil Aviation. In particular, the services include among others supervision of the Team of the Project Coordination Unit (PCU), work closely with the National Development Unit of the Department of Economic Development, Transport and Civil Aviation, as well with other focal points from other executing agencies and will be responsible for updating of the Project Implementation Manual, updating project plans and sub plans including communication, risk, and quality for effective and timely implementation of project activities and resource management and development for effective execution.

The Department of Economic Development, Transport and Civil Aviation now invites eligible individual consultants (“Consultants”) to indicate their interest in providing the Services. Interested Individual Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services; (Curriculum Vitae, description of similar assignments, experience in similar conditions, clients’ references etc). Interested Consultants should have the following requisite minimum qualifications and professional experiences listed below for undertaking the assignment.

- Masters’ degree in Engineering, Law, Economics or Accounting or related discipline with at least 5 years of relevant professional experience

OR

- Bachelors’ degree in Engineering, Law, Economics or Accounting or related discipline with at least 10 years of relevant professional experience

- Training in Disaster Risk Management and or Climate Change is an asset

- Training in International Procurement procedures is an asset
- Project Management certification

Professional experience includes:

- i) Project development, planning, and/or policy
- ii) Strategy development and implementation at the regional, national or subnational level.
- iii) Experience with Project Management tools and technology (ex: Gantt charts, Microsoft Project, Microsoft Planner, etc.)
- iv) Working on investment projects at the International, regional or national level
- v) Working with the private sector in project development, implementation and/or investments;
- vi) Proven track record of project management and project team experience working with government, lead funding agencies and other key stakeholders;

Experience:

- Demonstrated experience of a minimum of five (5) years in the project planning or project implementation,
- Experience managing large contracting programs and procurement based activities.
- Demonstrated experience in managing programs with international agencies such as World Bank, IADB, European Union or similar agency.
- Demonstrated experience with management of multidisciplinary programs.
- Demonstrated experience in projects focused in the Eastern Caribbean
