The **Government of Saint Vincent and the Grenadines** has received financing from the World Bank toward the cost of the **Human Development Service Delivery Project**, and intends to apply part of the proceeds toward payments under the contracts for **Procurement of TVET Training Materials to Enhance Schools**.
2. The **Economic Planning and Sustainable Development Division, within the Ministry of Finance, Economic Planning, Sustainable Development and Information Technology** now invites bids from eligible bidders for:
 - Lot 1: Masonry Tools and Equipment
 - Lot 2: Home Economics Supplies - Food
 - Lot 3: Home Economics Supplies - Clothing & Textile
 - Lot 4: Carpentry/Woodwork Supplies
 - Lot 5: Furniture Supplies
 - Lot 6: Technical Drawing Equipment
 - Lot 7: Electrical Supplies
3. Bidders may bid for one or several lots, as further defined in the request for bids (RFB) but the bidder must bid on all items and quantities in each lot. Bidders wishing to offer discounts in case they are awarded more than one contract will be allowed to do so, provided those discounts are included in the bid submitted.
4. Bidding will be conducted through Request for Bids (RFB) procedures as specified in the World Bank's [*Procurement in Investment Project Financing: Goods, works, non-consulting and consulting services*](#) ("Procurement Regulations"), and is open to all eligible bidders as defined in the Procurement Regulations. In addition, please refer to paragraphs 3.14 to 3.17 setting forth the World Bank's policy on conflict of interest.
5. Interested eligible bidders may obtain further information from The **Economic Planning and Sustainable Development Division, of the Ministry of Finance, Economic Planning, Sustainable Development and Information Technology** and inspect the bidding documents during office hours 9:00am to 3:00pm at **address #1** given below.
6. The bidding document in English may be acquired by interested eligible bidders upon the submission of a written application to the address below. The document will be sent via email.
7. Sealed Bids labeled "**Tender for the Procurement of TVET Training Materials to Enhance Schools**" must be delivered to **address #2** below on or before **10th August, 2020 at 2:00pm**. Electronic bidding will **NOT** be permitted. Late bids will be rejected. Thereafter bids

will be publicly opened in the presence of the bidders' designated representatives and anyone who chooses to attend at the address #2 below on **10th August, 2020 at 2:30pm.**
