



INVITATION TO TENDER



The Government of St. Vincent and the Grenadines in collaboration with the Caribbean Development Bank invites suitable contractors to tender for the **“Langley Park Feeder Road Upgrade, Langley Park”**.

The successful tender will be expected to:

- Provide statement of qualification,
- Procure all materials in accordance with the works,
- Construct the works in accordance with the Tender Documents, approved drawings, and the local building code,
- Be responsible for all labour costs connected with the construction
- Provide a detailed Method Statement for the works and an Environmental Management Statement

Scope of Work:

This includes but is not limited to the following:

- General clearance of land
- Defined excavation and earthworks
- Reinforced Concrete Carriageway (approx. 2,900x 16 ft wide)
- Rubble Stone Retaining Wall (approx. 350 x 6 ft high)
- Reinforced Concrete Box Drain (approx. 150 x 2 x 2 ft deep)
- Reinforced Blockwork Box Drain (400 x 3 x 3 ft deep)
- Reinforced Concrete Box Culvert (28 x 3 x 3 deep)
- Bridge Abutments Protection and Underpinning Works

Tender Process:

Tender Documents may be collected as of **Tuesday 15th October 2019 to Tuesday 12th November 2019** at the Office of the Chief Engineer, Ministry of Transport, Works, Urban Development and Local Government, St. Vincent and the Grenadines.

A Pre Bid meeting will be held on **Tuesday 22nd October 2019** at 9:00 am at the Ministry's Conference Room followed by a site visit on **Wednesday 23rd October, 2019** at 9:00 am. All prospective tenderers are expected to attend.

Contract

The successful applicant will be expected to enter into a contract with the Ministry of Transport, Works, Urban Development and Local Government.

Cost of Tender Documents & Method of Payment:

A non-refundable fee of EC\$ 350.00, payable to Accountant General, will be required for each Tender Document. Please note Tender Document should be collected at the natural disaster Management Coordinating Unit, Arnos Vale on demonstration of proof of payment.
