1. The Government of Saint Lucia has received financing from the World Bank toward the cost of the OECS Regional Health Project, and intends to apply part of the proceeds toward payments under the contract for the Procurement of Vehicles for Sample Transportation.
2. The Ministry of Health, Wellness and Elderly Affairs now invites bids from eligible bidders for the supply of two (2) Vehicles for Sample Transportation within three (3) – six (6) months. Margin Preferences shall not apply.
3. Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the World Bank’s “Procurement Regulations for IPF Borrowers” *July 2016, revised November 2017 and August 2018* (“Procurement Regulations”), and is open to all eligible Bidders as defined in the Procurement Regulations.
