#### Procurement of Goods for the Upgrade of Landfills

Saint Vincent and the Grenadines has received financing from the World Bank toward the cost of the SVG Unleashing the Blue Economy in the Caribbean Project and intends to apply part of the proceeds toward payments under the contract for Procurement of Goods for the upgrade of Landfills.

The Government of SVG (GoSVG) now invites sealed bids from eligible bidders for the supply of the following goods identified below in lots:

Lot 1: One (1) Tow – type of hydraulic feed woodchipper,

Lot 2: One (1) waste-master type telehandler,

Lot 3: One (1) crawler loader.

The bid is conducted on a lots basis. Bidders may be for one, two or three lots defined in the bidding documents. Bidders wishing to offer discounts in case they are awarded more than one contract will be allowed to do so, provided that the discounts are in the Form of a Bid or submitted in writing before the deadline for bid submission. All bids and offers of discounts shall be opened and evaluated simultaneously so as to determine the bid or combination of bids, including discounts, offering the lowest evaluated bid/s for the Purchaser. The Purchaser will award the contract/s to the lowest evaluated bidder/s for two, three or each lot determined on the basis of the lowest evaluated combined cost for the Purchaser for the entire package and who meet all post qualification criteria for the lot/s for which they are bidding.

The project site would be Central Water and Sewage Authority.

Procurement will be conducted through national competitive procurement using a Request for Bid (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" Fourth Edition November 2020 ("Procurement Regulations") and is open to all Suppliers as defined in the Procurement Regulations.

Interested eligible bidders may obtain further information from Economic Planning Division in the Ministry of Finance, Economic Planning, and Information Technology and inspect the bid document during office hours from 09:00 to 16:00 hours (9:00 a.m. to 4:00 p.m. SVG time) at the address given below.

Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who chooses to attend at the address below on September 22, 2023, at 1400hours (Local Time).

Lot 1: USD \$5,000.00,

Lot 2: USD \$3,500.00,

Lot 3: USD \$9,400.00.

Bid Security is required for each lot as per amounts indicated against each lot. Bidders have the option of submitting one Bid Security for all lots (for the combined total amount of all lots) for which Bids have been submitted, however if the amount of Bid Security is less than the total required amount, the Purchaser will determine for which lot or lots the Bid Security amount shall be applied.
