# Invitation for Initial Selection - Goods

The *Government of St. Vincent and the Grenadines* has received financing from the World Bank toward the cost of the *Unleashing the Blue Economy of the Caribbean (UBEC) Project – 3.0 Contingency Emergency Response Component (CERC)*, and intends to apply part of the proceeds toward payments under the contract (s) for *Bathymetric Surveys, Construction and Deployment of:*  
Lot 1: six (6) sub-surface FADs  
Lot 2: nine (9) surface FADs
2. The *Ministry of Finance, Economic Planning and Information Technology* intends to initially select Applicants for the conducting of Bathymetric Surveys, the construction and deployment of: 1) Lot 1: six (6) sub-surface FADs and 2) Lot 2: nine (9) surface FADs at pre-determined locations. For Lot 2, only six (6) of the surface FADs would be deployed while three (3) would be kept as spares by the Fisheries Division in the Ministry of Agriculture, Forestry, Fisheries, Rural Transformation, Industry and Labour.
3. It is expected that the Request for Proposals will be made in September 2023.
4. Initial Selection will be conducted through the procedures as specified in the World Bank's Procurement Regulations for IPF Borrowers *Fourth Edition November 2020* ("*Procurement Regulations*") ("*Procurement Regulations*"), as outlined in the Initial Selection documents, and is open to all eligible Applicants as defined in the Procurement Regulations.
